**INTRODUCTION**

This document is a Consent Agreement regarding Michelle G. Abbott's license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 32 M.R.S.A. § 2105-A (1-A) (A), 10 M.R.S.A. § 8003(5) (A-1) (1) and § 8003(5) (B). The parties to this Consent Agreement are Michelle G. Abbott ("Licensee" or "Ms. Abbott"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine.

**FACTS**

1. Michelle G. Abbott has been a registered professional nurse licensed to practice in Maine since March 16, 1987.
2. Michelle G. Abbott renewed her license January 29, 2007 and failed to disclose that she was convicted for "Operating Under the Influence," which is a Class D misdemeanor.

**AGREEMENT**

3. Michelle G. Abbott understands that her conduct in the above-stated facts constitutes grounds for discipline under Title 32 M.R.S.A. § 2105-A (2) (F), unprofessional conduct because she provided misleading information on her renewal application for licensure as a registered professional nurse.
4. Michelle G. Abbott understands that this document is a Consent Agreement that may affect her rights to practice nursing in the State of Maine and any party state in the Nurse Licensure Compact. Ms. Abbott understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into the Consent Agreement.
5. Michelle G. Abbott affirms that she executes this Consent Agreement of her own free will.
6. Modification of this Consent Agreement must be in writing and signed by all the parties.
7. This Consent Agreement is not subject to review or appeal by the Licensee.

8. This Consent Agreement becomes effective upon the date of the last necessary signature below.




