Dear Ms. Allen:

This is to follow up on Jean Caron's April 13, 1992 letter to you regarding the denial by the Maine State Board of Nursing of your request to activate your Maine registered professional nurse license. As Ms. Caron indicated, the factual basis for the Board's decision was the 1988 Order from the Nevada Board of Nursing. The statutory grounds for the Board's action are 32 M.R.S.A. § 2105-A(2)(F), unprofessional conduct, and 32 M.R.S.A. § 2105-A(2)(A), fraud or deceit in obtaining a license.

Pursuant to 32 M.R.S.A. § 2105-A(1-A) and 5 M.R.S.A. § 10003, you have the right to a hearing before the Board on this matter. Should you desire such a hearing, please submit a written request for a hearing to Jean C. Caron, R.N., M.S., Executive Director of the Maine State Board of Nursing, at State House Station #158, Augusta, Maine, 04333.
