## INTRODUCTION

This document is a Consent Agreement regarding Mary Ellen B. Allen's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(C) (1988). The parties to this Consent Agreement are: Mary Ellen B. Allen, R.N., the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

By letter dated July 18, 1989, Mary Ellen B. Allen was advised by the Board that it had received a letter from Mary B. Williams, R.N., Vice President for Patient Care, Eastern Maine Medical Center, alleging diversion of drugs from the Eastern Maine Medical Center in Bangor, Maine. Ms. Allen responded to the Board's letter on July 27, 1989. Subsequently, the Board requested that Ms. Allen attend an informal conference pursuant to 32 M.R.S.A. Section 2105-A(1-A). At the informal conference held on September 14, 1989, Ms. Allen was present and represented by her attorney, Charles W. March, Esq.

# FINDINGS OF FACT

As a result of the informal conference, the Board made the following findings of fact:

- 1. Ms. Allen admitted to diverting Demerol to her own use.
- 2. There is no indication of patient harm due to her diversion.
- 3. Ms. Allen has completed the Nightingale Rehabilitation Program for nurses who are chemically dependent.
- 4. Ms. Allen has been substance free since July 7, 1989.
- 5. There is no prior history of substance abuse.
- 6. Ms. Allen is actively involved in aftercare and support groups.

7. Ms. Allen has a good support system.

## COVENANTS

Based on the above findings of fact, the Board voted to place Ms. Allen's license on a probationary status for two years commencing on September 14, 1989 and agreed to the following terms and conditions:

- 1. Ms. Allen shall remain substance free.
- 2. Ms. Allen shall continue with her aftercare treatment.
- 3. Ms. Allen shall arrange for quarterly reports to be submitted to the Board by her substance abuse counselor responsible for the aftercare treatment.
- 4. Ms. Allen shall arrange for her nurse employer(s) to send quarterly reports to the Board regarding her performance.
- 5. Ms. Allen shall share this Consent Agreement with her nurse employer(s).
- 6. Ms. Allen hereby waives all claims of confidentiality and privilege she may have regarding reports to be submitted to the Board in accordance with this Consent Agreement.
