INTRODUCTION

This document is a Consent Agreement regarding Carolee Boisvert's license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 32 M.R.S.A. § 2105-A(1-A)(C) and 10 M.R.S.A. § 8003(5)(B). The parties to this Consent Agreement are Carolee Boisvert ("Licensee"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. The parties reached this Agreement on the basis of information submitted by (1) Long Creek Youth Development Center; & (2) The Matthew I. & Evelyn A. Barron Center ("Barron Center") and Ms. Boisvert's request to voluntarily surrender her registered professional nurse license through telephone conversation with the Board's Executive Director and Assistant Attorney General February 9 and 10, 2005.

FACTS

- 1. Carolee Boisvert has been a registered professional nurse licensed to practice in Maine since 1996.
- 2. On February 24, 2003 Ms. Boisvert was terminated (while still on probation) from the Long Creek Youth Development Center due to mistakes and call-outs. On July 2, 2003, Ms. Boisvert was terminated from the Barron Center because of a discrepancy in a patient's medication administration records, which could not account for a missing tab of Oxycodone. Ms. Boisvert states that she has a seizure disorder and does not recall a lot of the details that occurred on the shift when this incident occurred.
- 3. Carolee Boisvert admits that she is unable to work as a registered professional nurse because of the seizure disorder and is currently under treatment with a physician.
- Carolee Boisvert has offered to voluntarily surrender her registered professional 4. nurse license in lieu of a formal adjudicatory hearing before the Board.

- 5. The Maine State Board of Nursing will accept Carolee Boisvert's voluntary surrender of her registered professional nurse license.
- 6. Carolee Boisvert agrees and understands that the Board is accepting the voluntary surrender of her registered professional nurse license pursuant to 32 M.R.S.A. § 2105-A(2)(C) and (2)(H) and Chapter, 4(3)(N) of the Rules and Regulation of the Maine State Board of Nursing, because she is unfit to perform procedures and make decisions in accordance with the license held as a result of a physical impediment.
- 7. Carolee Boisvert may petition the Board for reinstatement of her license, however before she is reinstated Ms. Boisvert must meet with the Board to address the issues in the above stated facts. Ms. Boisvert agrees and understands that her license will not be reinstated until and unless the Board, upon Ms. Boisvert's written request, votes to reinstate Ms. Boisvert's license.
- 8. Carolee Boisvert shall not work or volunteer, in any capacity, for a health care provider as defined by Title 24 M.R.S.A. § 2502 (2) or in any position holding herself out as a registered professional nurse or with the designation, R.N. including, in a veterinarian's office, while her nursing license is surrendered. In addition, Ms. Boisvert is not to seek employment where the handling or dispensing of drugs is part of the job responsibility.
- 9. Carolee Boisvert understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
- 10. Carolee Boisvert affirms that she executes this Consent Agreement of her own free will.
- 11. Modification of this Consent Agreement must be in writing and signed by all parties.
- 12. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.

- 13. This Consent Agreement becomes effective upon the date of the last necessary signature below.
- I, CAROLEE BOISVERT, HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING IT, I WAIVE CERTAIN RIGHTS. I SIGN IT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.
