This Consent Agreement is entered into by and among Kevin Brekke, R.N., the Maine State Board of Nursing (hereinafter "the Board") and the Department of the Attorney General, State of Maine. On June 21, 1986, Mr. Brekke entered into an Administrative Consent Decree pursuant to 32 M.R.S.A.

§ 2105-C(1) wherein he agreed to practice as a registered curse on a probationary status for one year beginning January 21, 1986. On June 25, 1987, Mr. Brekke appeared before the Board of Nursing represented by counsel to petition for reinstatement of his license to practice nursing in the State of Maine.

A. FINDINGS OF FACT

At its meeting of June 21, 1986, the Board found that:

1. The terms of the above-mentioned 1986 Consent Agreement had not been met in that Mr. Brekke did not comply with the number of counseling appointments required by said Agreement.

B. COVENANTS

Pursuant to 32 M.R.S.A. § 2105-A(1)(C), the Board voted to deny reinstatement of Mr. Brekke's license. Rather, the Board voted to continue Mr. Brekke's license to practice nursing in the State of Maine on a probationary status for one year under the following conditions:

- 1. Mr. Brekke must continue in counseling with a registered substance abuse counselor for one year.
 - 2. Mr. Brekke must remain chemical free.
- 3. Reports from Mr. Brekke's certified substance abuse counselor must be sent to the Board every two months for the following six months from the date of the signature of this Agreement. Such reports are then due quarterly to the Board of Nursing from said substance abuse counselor or from the institution employing such counselor. Mr. Brekke further agrees that the Board may contact the reporters for further information. Mr. Brekke thus waives any claim of privilege he may have regarding these reports.
- 4. If Mr. Brekke remains employed in nursing, then his employer must submit reports to the Board within the same time frame as mentioned above, i.e., reports every two months for six months following the date of signature of this Agreement and then quarterly.

Mr. Brekke's signature below evidences that he has read and understands the above agreement and the conditions set forth herein.
