INTRODUCTION

This document is a Modified Consent Agreement regarding Janice M. Chamberland's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(B). The parties to this Consent Agreement are: Janice M. Chamberland, R.N., the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine. These same parties entered into a Consent Agreement on October 19, 1990. Pursuant to that Agreement, Ms. Chamberland voluntarily surrendered her license to the Board.

By letter dated September 16, 1991, Ms. Chamberland requested that the Board consider reinstating her license to practice. A meeting with the Board was held on October 1, 1991, at which Ms. Chamberland appeared with her attorney, John C. McCurry, Esq. At that meeting, the Board voted to modify the covenants of the October 19, 1990 Consent Agreement as follows:

COVENANTS

Ms. Chamberland's license to practice professional nursing in the State of Maine is hereby reinstated on a probationary status for a period of one year with the following conditions:

- 1. Licensee will remain completely substance-free.
- 2. Licensee will arrange to have quarterly reports submitted to the Board from her nurse employer and from her counselor. Licensee waives any claims of confidentiality and privilege which she may have with respect to these reports.
- 3. Licensee will continue in her aftercare program as long as prescribed by her counselor.

- 4. Licensee will immediately notify the Board of any change in her employment.
- 5. Licensee will continue in her recovery program.
- 6. The Board agrees to take no further action upon these facts so long as the licensee fully complies with these conditions.

Ms. Chamberland understands that this document is a Modified Consent Agreement which affects her rights to practice nursing in Maine. Ms. Chamberland understands that she does not have to execute this Modified Consent Agreement and that she has the right to consult with an attorney before entering this Modified Consent Agreement. Ms. Chamberland affirms that she executes this Modified Consent Agreement of her own free will.
