## INTRODUCTION

This document is a Consent Agreement regarding Rebecca S. Davis' license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105A(1A)(A). The parties to this Consent Agreement are Rebecca S. Davis ("Licensee"), Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine. An informal conference was held on March 15, 2002. The parties reached this Agreement on the basis of information submitted by the Acadia Hospital, Bangor, Maine in a letter dated August 15, 2001.

## **FACTS**

- 1. Rebecca S. Davis has been a registered professional nurse licensed by the Board to practice in Maine since June 2000.
- 2. Rebecca S. Davis provided false information on her application for licensure to the Maine State Board of Nursing. This was discovered when she failed to disclose that she had a prior criminal conviction on her job application at the Acadia Hospital ("Acadia"). This led to her termination at Acadia, which was reported to the Board. The information Ms. Davis failed to disclose was a misdemeanor conviction in July 19, 1996, of Criminal Mischief, Class D crime (17-A M.R.S.A. § 806), in which she received a fine of \$100.00.

## **AGREEMENT**

- 3. Rebecca S. Davis agrees and understands that her conduct constitutes grounds for discipline under Title 32 M.R.S.A. § 2105-A(2)(A),(2)(F), (2)(H), and Chapter 4.1.A.6. Rebecca S. Davis is hereby **WARNED** because she provided false information in obtaining her nursing license and she engaged in unprofessional conduct.
- 4. Rebecca S. Davis understands that this Consent Agreement imposes discipline regarding her license to practice registered professional nursing in the State of Maine. Ms. Davis understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
- 5. Rebecca S. Davis affirms that she executes this Consent Agreement of her own free will.

- 6. Modification of this Consent Agreement must be in writing and signed by all the parties.
- 7. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.
- 8. This Consent Agreement becomes effective upon the date of the last necessary signature below.

I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.
