This Consent Agreement arises out of an informal conference held June 7, 2000 and amends the Consent Agreement executed October 26, 1999. In addition to findings and covenants established in the former Consent Agreement, the Board finds that:

- 1. You failed to inform your employer of the Consent Agreement executed October 26, 1999 per Agreement provision 6.a.
- 2. You failed to ensure submission of quarterly reports from your employer per Agreement provision 6.b.
- 3. You failed to ensure submission of quarterly reports from your counselor per Agreement provision 6.c.
- 4. You failed to provide quarterly reports from your nursing employer(s) and counselor.

On the basis of these facts it was agreed as follows:

- 1. The Board agrees to take no further disciplinary action upon these facts as long as Ms. Gage fully complies with the terms and conditions of this and the prior Consent Agreement executed October 26, 1999.
- 2. Mary Gage's probation is extended for a period of six months, beginning on June 8, 2000. Ms. Gage agrees and understands that her license will remain on probationary status and subject to the terms of this Agreement beyond the six month period, until and unless the Board, at Ms. Gage's written request, votes to terminate Ms. Gage's probation. When considering whether to terminate the probation, the Board will consider the degree to which Ms. Gage has complied with the provisions of this Agreement.
- 3. Mary Gage will submit to a substance abuse evaluation by a licensed substance abuse counselor at the Boards expense.



5. The Consent Agreement becomes effective upon the date of the last ncesssary signature below.

## **INTRODUCTION**

This document is a Consent Agreement regarding Mary A. Gage's license to practice professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. Section 8003(5)(A-1)(4) and 32 M.R.S.A. Section 2105-A(1-A)(B). The parties to this Consent Agreement are: Mary A. Gage, Maine State Board of Nursing ("Board") and the Department of the Attorney General. The parties reached this Agreement following an informal conference on June 9, 1999 regarding information submitted by OakGrove & The Willows Rehabilitation and Living Centers thru letters dated August 12, 1998 and March 19, 1999.

## **FACTS**

- 1. Ms. Gage was terminated from employment at OakGrove & The Willows Rehabilitation and Living Centers for excessive absenteeism.
- 2. Ms. Gage admits to using alcohol for treatment purposes to enhance sleep.
- 3. Ms. Gage has been a licensed nurse for twenty years
- 4. Ms. Gage is currently in counseling

### **AGREEMENT**

5. Ms. Gage agrees and understands that her conduct constitutes grounds for discipline under 32 M.R.S.A. Section 2105-A(2)(A), (2)(B), (2)(E), (2)(F) and (2)(H).

- 6. Ms. Gage's license to practice professional nursing in the State of Maine in on probation. The period of probation will continue for a period of six months of nursing employment. Ms. Gage's license is subject to the following conditions:
  - a. Notice to employer: Ms. Gage will notify any and all of her nursing employers of the terms of the Consent Agreement and shall provide them with a copy of it. For purposes of this Consent Agreement, nursing employment is any employment during which Ms. Gage performs nursing services or holds herself out as a nurse, such as through the designation "RN".
  - b. <u>Employer quarterly reports:</u> Ms. Gage will arrange for and ensure the submission to the Board of quarterly reports addressing her professional conduct from her nursing employer(s).
  - c. <u>Letter from counselor</u>: Ms. Gage will arrange for and ensure the submission to the Board of quarterly reports from her counselor addressing her progress and ability to perform her professional duties as a nurse.
  - d. <u>Waiver of Confidentiality</u>: Ms. Gage waives any claims of confidentiality between herself and her counselor in order to allow her counselor to give a full and fair report to the Board.
  - e. <u>Notice of employment status:</u> Ms. Gage will immediately notify the Board in writing of any employment in the field of nursing, including the place and position of employment, and any change in nursing employment thereafter.
  - f. Term of probationary status: Ms. Gage agrees and understands that her license will remain on probationary status and subject to the terms of this Agreement beyond the six (6) month period, until and unless the Board, at Ms. Gage's written request, votes to terminate Ms. Gage's probation. When considering whether to terminate the probation, the Board will consider the degree to which Ms. Gage has complied with the provisions of this Agreement.
- 7. Ms. Gage understands that this document imposes discipline regarding her license as a registered professional nurse in the State of Maine. Ms. Gage understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering the Consent Agreement. Modification of this Consent Agreement must be in writing and signed by all parties. Ms. Gage affirms that she executes this Consent Agreement of her own free will.
