## ADMINISTRATIVE CONSENT AGREEMENT

On February 16, 1982, the Maine State Board of Nursing considered a request by Michael J. Grace to reinstate his registered nurse license, which was revoked by the Maine Administrative Court on January 9, 1980.

After consideration of recent reports from his counselor, probation officer and current work supervisors, and after meeting with Mr. Grace on February 16, 1982, the Board has determined, upon advice of legal counsel, that Mr. Grace may resume his practice of nursing and hereby reinstates his license to practice as a registered nurse, subject to the following conditions:

- (1) Mr. Grace will voluntarily enter into a probationary period of one year, beginning on the date of employment in nursing;
- (2) During the period of probation, Mr. Grace will inform each of his employers of the terms and conditions of this agreement;
- (3) Mr. Grace will submit to the Board every three months written documentation from his nurse supervisior as to his work performance.
- (4) Mr. Grace will meet with the Board every six months during the period of probation.

At the end of the one year probationary period, the Board will determine whether further restrictions are necessary and, if they are not necessary,

will allow Mr. Grace to practice as a registered nurse without these restrictions.

It is understood, however, that if for any reason Mr. Grace fails to fulfill any of his obligations under this agreement, the Board of Nursing will be released from all of its obligations under this agreement and will be free to take whatever steps it considers appropriate.
