ADMINISTRATIVE CONSENT AGREEMENT

On Wednesday, January 12, 1983, the Maine State Board of Nursing (hereinafter "the Board") met with Randy L. Johnson, R.N., at its offices located at 295 Water Street, Augusta, Maine. Mr. Johnson acknowledged that he has had a problem involving the use of drugs which led to his voluntary surrender on December 22, 1982 of his license to practice professional nursing in Maine. On January 12, 1983 Mr. Johnson voluntarily surrendered his license to practice practical nursing in the State.

Based on his presentation before the Board, the Board believes that Mr. Johnson's drug related problem is under control and that his practice of nursing poses no threat to the health and safety of the public. Because of Mr. Johnson's admissions regarding his drug related problem and his willingness to seek therapy to overcome this problem, the Board wishes to resolve this matter without filing an action in Administrative Court. Therefore, Mr. Johnson and the Board hereby agreed to the terms of the following consent agreement:

(1) The Board agrees to reinstate Mr. Johnson's license to practice professional nursing, as well as his

license to practice practical nursing, effective upon the date this agreement is entered into and signed below by Mr. Johnson, under a probationary status for a period of two (2) years from the date of reinstatement;

- (2) During this two (2) year period Mr. Johnson agrees to continue his out-patient treatment program for his drug related problem;
- (3) Mr. Johnson agrees to submit a written report from both his nursing supervisor and his drug counselor to the board every three (3) months for two (2) years concerning his progress towards rehabilitation;
- (4) Mr. Johnson agrees to make arrangements with his employer or other appropriate person(s) to administer unscheduled urine tests to determine Mr. Johnson's abstinence from scheduled drug abuse and to have the results of such tests submitted to the Board for a period of two (2) years. The Board reserves the right to approve or direct the frequency of the unscheduled urine tests;
- (5) Mr. Johnson agrees to meet with the Executive Director and a member of the Board every six (6) months for two (2) years at the Board office located at 295 Water Street, Augusta, Maine to discuss

Mr. Johnson's progress towards rehabilitation.

It is understood that if for any reason Mr. Johnson fails to fulfill any of his obligations under this agreement the Board will be released from all its obligations under this agreement and will be free to take whatever action it deems appropriate.
