AMENDED CONSENT AGREEMENT REGARDING PROBATIONARY STATUS OF LICENSE

## INTRODUCTION

This document is a Consent Agreement regarding Karen Schooley Manson's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(B). The parties to this Consent Agreement are: Karen Schooley Manson, R.N., formerly Karen M. Schooley, R.N.; the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

In January of 1992 these parties entered into a Consent Agreement pursuant to which Ms. Manson's license was placed on probation for a period of one year from December 17, 1991 with certain conditions of probation. Ms. Manson requested reinstatement of her license and met with the Board on February 11, 1993. At that time the Board decided to extend the probationary status of Ms. Manson's license for one additional year beginning December 17, 1992, again with certain conditions of probation. This Amended Consent Agreement reflects that decision.

## COVENANTS

The Board voted to extend the January 1992 agreement with Ms. Manson under which her license was placed on probation, for a period of one additional year from December 17, 1992, with the following conditions:

- 1. Ms. Manson will arrange to have quarterly reports submitted to the Board from her nurse employer. Ms Manson waives any claims of confidentiality and privilege which she may have with respect to these reports.
- 2. Ms. Manson will continue in all prescribed facets of her aftercare program and will arrange to have quarterly reports submitted to the Board from her counselor, including notification in these reports of any change in Ms. Manson's level of commitment to her recovery. Ms.

Manson waives any claims of confidentiality and privilege which she may have with respect to these reports.

- 3. Ms. Manson will notify the Board of any change in her employment.
- 4. Ms. Manson will remain substance-free.
- 5. Ms. Manson will notify any nurse employer of the existence of this Amended Consent Agreement and of its terms.
- 6. The Board agrees to take no further action at this time upon these facts so long as Ms. Manson fully complies with these conditions. The Board reserves the right to reconsider this matter and take further action, should it receive additional reports containing significant additional information regarding this matter.

Ms. Manson understands that this document is an Amended Consent Agreement which affects her rights to practice nursing in Maine. Ms. Manson understands that she does not have to execute this Amended Consent Agreement and that she has the right to consult with an attorney before entering this Amended Consent Agreement. Ms. Manson affirms that she executes this Amended Consent Agreement of her own free will.
