ADDITIONAL PROBATION CONDITIONS

- I if medication is prescribed by any physician, the medication must be taken in the manner and quantity directed by the physician, and must only be possessed in the bottle it was dispensed in.
- 2. All prescribed medication must be identified to the probation on the day it is prescribed.
- 3. You must keep a daily medication log, identifying the type of medication taken, the amount taken, and the time taken.
- 4. You must designate a primary physician to your probation officer. No other physician, physician's assistant or family nurse practitioner may be seen without a written referral from the primary physician.
- 5. You must execute medical release forms to allow your probation officer to have an open line of communication with the primary physician and any other professionals to whom you may be referred.
- 6. You must designate a primary pharmacy to your probation officer. No other pharmacy may be used without prior approval from your probation officer.
- 7. You must personally retrieve all of your medications from the pharmacy. You may not retrieve medication for any other person without prior approval from your probation officer.
