**INTRODUCTION**

This document is a Consent Agreement regarding Lisa A. Saylor's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(B). The parties to this Temporary Consent Agreement are: Lisa A. Saylor, R.N., the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

By letter dated December 19, 1996, Ms. Saylor was advised by the Board that it had received a letter dated December 10, 1996 from Michael Faucher, Administrator, Viking Nursing Care, containing information of possible violations of 32 M.R.S.A. Section 2105-A (2)(B), (2)(E) and (2)(F) arising from allegations that Ms. Saylor reported to work at Viking Nursing Care on November 30, 1996 while intoxicated.

Subsequently, by letter dated March 28, 1997, Ms. Saylor was advised by the Board that it had received a letter dated March 19, 1997 from Pamela Drown, R.N., Director of Nursing Services at The Renaissance, containing information of possible violations of 32 M.R.S.A. Section 2105-A(2)(E), (F), and (H) arising from Ms. Saylor's employment at The Renaissance, including allegations of sleeping on duty and multiple medication errors.

On September 10, 1997, Ms. Saylor attended an informal conference with the Board pursuant to 32 M.R.S.A. Section 2105-A(1-A). As a result of the informal conference on September 10, 1997, the parties agreed to enter into this Temporary Consent Agreement.

**AGREEMENT**

1. Ms. Saylor will voluntarily surrender her license and the informal conference, commenced on September 10, 1997, will be continued until after Ms. Saylor has been evaluated by an addictionologist and by a psychiatrist in accordance with this agreement.
2. Ms. Saylor agrees to be evaluated for possible substance abuse by an addictionologist chosen by the Board. The Board will incur the cost of this evaluation.
3. Ms. Saylor agrees to be evaluated by a psychiatrist chosen by the Board for the purpose of evaluating Ms. Saylor's mental status. The Board will incur the costs of this evaluation.
4. While this Temporary Consent Agreement is in effect, Ms. Saylor will not work in any capacity in the health care field (including a veterinarian's office).
5. Ms. Saylor waives any claims of confidentiality and privilege which she may have with respect to the evaluations to be performed pursuant to this Temporary Consent Agreement.


6. Ms. Saylor will arrange for and ensure that copies of her counseling records are made available to the addictionologist and to the psychiatrist. Ms. Saylor will execute any and all necessary medical releases requested by the Board or by the addictionologist and psychiatrist.
7. This Agreement is not intended to prohibit the Board from obtaining additional information pursuant to request or subpoena regarding this matter.
8. The Board reserves the right to take further disciplinary action with respect to this matter.
9. Ms. Saylor understands that this document is a Temporary Consent Agreement which affects her right to practice nursing in Maine. This Temporary Consent Agreement may be amended only in writing, signed by all the parties. Ms. Saylor understands that she does not have to execute this Temporary Consent Agreement and that she has the right to consult with an attorney before entering this Temporary Consent Agreement. Ms. Saylor affirms that she executes this Temporary Consent Agreement of her own free will.
10. This Temporary Consent Agreement becomes effective upon the last necessary signature below.
