## INTRODUCTION

This document is a Consent Agreement regarding Debra A. Webb's license to practice practical nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105-A(1-A)(A) and (B). The parties to this Consent Agreement are Debra A. Webb ("Licensee"), Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine. The parties reached this Agreement following an informal conference held on June 7, 2000 on the basis of information submitted by the State of Maine, Department of Human Services, Bureau of Medical Services, Division of Licensing and Certification by letter dated February 23, 1999 and supporting documentation and complaint investigation No. 99-A-NF-309.

## **FACTS**

- 1. Debra A. Webb has been a licensed practical nurse licensed by the Board to practice in Maine since August 3, 1994.
- 2. On February 4, 1999 the Department of Human Services-Bureau of Medical Services, Division of Licensing and Certification conducted an investigation at Amenity Manor to investigate a complaint against Debra A. Webb regarding patient care.
- 3. The Board finds that the investigation conducted by DHS in conjunction with Ms. Webb's admissions substantiates that Ms. Webb failed to take appropriate action and to follow policies and procedures in the nursing practice situation designed to safeguard a patient.
- 4. The Board finds that no actual patient harm occurred as a result of Ms. Webb's actions.

## **AGREEMENT**

- 5. Debra A. Webb agrees and understands that her conduct constitutes grounds for discipline under 32 M.R.S.A. § 2105-A(2)(F) and (2)(H). Debra A. Webb is hereby **WARNED**. Ms. Webb is hereby **WARNED** because she failed to take appropriate action and to follow policies and procedures in the nursing practice designed to safeguard a patient.
- 6. Debra A. Webb understands that this Consent Agreement imposes discipline regarding her license to practice practical nursing in the State of Maine. Ms. Webb understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
- Debra A. Webbs affirms that she executes this Consent Agreement of her own free will.
- Modification of this Consent Agreement must be in writing and signed by all the parties.



9. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.10. This Consent Agreement becomes effective upon the date of the last necessary signature below.

I, DEBRA A. WEBB, L.P.N., HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING IT, I WAIVE CERTAIN RIGHTS. I SIGN IT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.
