To License a Dangerous or Nuisance Dog, we recommend a different process for licensing than for other dogs.

Start by searching for your dog. If the dog is in the system, select the clicking the blue Dog ID number for that dog to navigate to the dog record.

To Designate a dog as a Dangerous or Nuisance Dog, click the Danger Box and select the Danger or Nuisance Status. In most cases for Licensing this will be a choice between the two ADJUDICATED options. You can also update the Bitten Status if the designation is due to a bite. It is best practice for as much information as possible to be added here to the dog detail for Dangerous and Nuisance dogs. Click SAVE.

Once saved, you will see the Danger Icon on the dog's detail page. You will also see the specific Danger information and Bite Status under details.

Some Courts require a photo to be provided to the ACO/Municipality. You can add that by clicking on the Photos/Video tab and uploading the photo(s). Some courts require Microchips, and that can be added under the Identifications tab. Copies of a Court Order or any other document can be added under Memos/Files.



Once the dog detail is updated, go to the ADD LICENSE section of the database.



Next create an OWNERSHIP relationship by going to the Ownership module. Click on the green + icon and select "Ownership" in the drop-down.
