Contrary to the assertions in this appeal, granting this appeal (and admitting these materials into the hearing record) would, in fact, prejudice CMP and the other parties. We are preparing rebuttal testimony based on the decision to strike these materials, and to now reverse that decision and allow these materials into the hearing record would be prejudicial because there is insufficient time available to respond to these materials by the March 21 deadline for submission of rebuttal testimony. Alternatively, a delay of the hearing to allow the parties to address these materials also would prejudice CMP. Thus, it would prejudice CMP if Groups 2 and 10 are not required to comply with the clearly articulated rules set forth in the procedural orders.
