

P1: Panoramic view looking north from the southern end of Lower Lead Mountain Lake in T28 MD. Lower Lead Mountain Lake is rated as Significant in the <u>Maine Wildlands Lake</u> <u>Assessment</u>. The Bull Hill Wind Project (Project) will not be visible from this lake due to intervening vegetation and topography.



P2: Continued panoramic view looking northeast from the public boat landing at Lower Lead Mountain Lake.



P3: Panoramic view looking southeast to south from the northeast shore of Spectacle Pond in Osborn. This Lake is not rated for scenic resources in the <u>Maine Wildlands Lake Assessment</u>.



P4: Continued panoramic view looking south to southwest from the northeast shore of Spectacle Pond.



P5: View looking east from the intersection of Abrams Pond Road and Eastbrook Road, at Dickens Farms, in Eastbrook. Portions of 5 turbines may be visible from this viewpoint during leaf off conditions at 5.3 miles.



P6: View looking east from Sugar Hill Road, near Fire Lane 20, in Eastbrook. Tips of blades from 2 or 3 turbines may be visible from this location at a distance of 2.8 miles.



P7: View looking east from Sugar Hill Road, west of the north shore of Molasses Pond, in Eastbrook. Portions of 5 turbines may be visible from this viewpoint at 3.6 miles.

P8: View of a communication tower on Sugar Hill Road, located approximately one mile to the west of the southernmost turbine.



P10: View looking north at blueberry barrens off Sugar Hill Road, near Bog River Road, in Eastbrook. Turbines will not visible from this clearing, located approximately 1.5 miles to the west of the Project, due to intervening vegetation.



P9: Several new homes have been built recently on Sugar Hill Road to take advantage of the southerly views toward Molasses Pond. This view is looking north at a home near the intersection of Sugar Hill Road and Smith's Mine Road in Eastbrook.




P14: Panoramic view looking east from the Eastbrook Baptist Church and Townhouse. The Project will not be visible from this structure due to intervening topography and vegetation.



P15: Panoramic view looking west from Route 200 / East Brook Road toward the Eastbrook Baptist Church and Townhouse.





P17: Panoramic view looking east from Abbott Lane, north of Sugar Hill Road intersection, in Eastbrook. Portions of the northern and southern clusters of turbines will be visible at distances of 4.2 and 3.9 miles, respectively.



P18: Panoramic view looking north to northeast from the west shoreline of Webb Pond in Waltham. Webb Pond is not rated for scenic resources in the <u>Maine Wildlands Lake</u> <u>Assessment.</u>



P19: Continued panoramic view looking northeast to east from west shoreline of Webb Pond. Up to eight turbines will be visible at distances of 6.7 to 7.6 miles.




P20: Panoramic view looking north to northeast from Butler Cove on the southern shoreline of Molasses Pond in Eastbrook. The tips of a few turbines may be visible above the treeline at distances of 3.1 to 4.9 miles. Molasses Pond is not rated for scenic resources in the <u>Maine Wildlands Lake Assessment</u>.



P21: Panoramic view looking northeast to east from southwestern shoreline of Molasses Pond in Eastbrook. Upper portions of up to eight turbines will be visible at distances of 3.2 to 4.7 miles.



P22: Panoramic view looking east to southeast from the public beach off Molasses Pond Road on the northern shore of Molasses Pond in Eastbrook. Three turbines will be visible from this viewpoint at distances of 3.4 to 3.8 miles.



P23: Continued panoramic view looking southeast to south from Molasses Pond Road. The radio tower on Martin Ridge is visible 4.7 miles away.



P24: View of the R. Lyle Frost Wildlife Management Area sign and boat launch on the northern end of Scammon Pond off Sugar Hill Road in Eastbrook.



P25: View looking east from the boat launch on Scammon Pond. The Project will not be visible from this viewpoint or the majority of the pond.



P26: Another panoramic view looking east over Scammon Pond from a point slightly east of the boat launch. Scammon Pond is not rated for scenic resources in the <u>Maine Wildlands</u> <u>Lake Assessment</u>.



P27: Panoramic view looking north to northeast from Bunker Beach Road on Georges Lake in Franklin. Views of the Project will be screened from this viewpoint by the evergreen vegetation on the far shoreline. Georges Lake is not rated for scenic resources in the <u>Maine Wildlands Lake Assessment</u>.



P28: Continued panoramic view looking northeast to east from Bunker Beach Road on Georges Lake in Franklin.

P35: Panoramic view looking northeast to east from the northern end of Narraguagus Lake in T16 MD. Views from this area are oriented southward toward Tunk, Black, and Schoodic Mountains. The Project will not be visible from this viewpoint.



Twelve turbines will be visible from this viewpoint at distances of 7.8 to 10.7 miles. Six turbines will be within 8 miles of this viewpoint. See Photosimulation 4 in Appendix C.



P54: Continued panoramic view looking northeast from 0.4 miles north of Schoodic Beach on Donnell Pond. Black Mountain is seen on right in photo.



P55: View of the 20 car parking lot at the Card Mill boat launch on the western most point of Donnell Pond in Franklin. According to the <u>Downeast Region Management Plan</u>, this parking lot is often full and over flowing with cars from recreational users.



P56: Panoramic view looking east from Card Mill boat launch on the western end of Donnell Pond. Approximately 50 cottages, most with docks and floats, line the waterfront. The Project would not be visible from the boat launch or this cove.

P63: View of camping area on Redmans Beach (aka Black Beach), on the eastern shore on Donnell Pond. The Project would not be visible from the beach.




P62: View looking toward the conservation area on the northwest side of Donnell Pond near Bear Point. The Project will not be visible from this beach location.






P117: Panoramic view looking north from a small clearing at the highest point along the Caribou Mountain trail. There are no distant views in any direction from this viewpoint.
