<u>Project and Organizational Change Management for Medicaid Enterprise System</u> <u>Health PAS Modernization Process</u>

I. Summary

The State of Maine, Department of Administrative and Financial Services, Project Management Office is seeking to procure Project Management (PM) and Organizational Change Management (OCM) support services for the Medicaid Enterprise System (MES) Health PAS (HPAS) Modernization Process on behalf of the Maine Department of Health and Human Services (DHHS). The awarded Bidder will be responsible for working with the project's implementation vendor, Gainwell, to ensure the modernization process is completed and up to the standards expected by the Project Management Office (PMO), DHHS, and the State of Maine.

II. Evaluation Process

An evaluation team of four individuals reviewed proposals submitted by bidders. The team consisted of two members of the Office of Mainecare Services (OMS) and two members of the PMO. Both OMS members work within the team that is receiving the modernization. The PMO members were subject matter experts for PM and OCM.

Members of the proposal evaluation team completed individual reviews of each submitted proposal, then met as a team over three days to assign consensus scores for each proposal. The team evaluated bids by file in alphabetical order. Starting in order with File 1 and File 2 being reviewed on the first day, then File 3 being reviewed on the second and third day. The results of File 4's scoring (Cost) was reviewed by the team once File's 1-3, were fully scored.

After the scoring was complete, Public Consulting Group was the highest scoring bid.

III. Qualifications & Experience

Nine of the eleven Bidders provided experience and qualifications that aligned with the requirements of the RFP. Two of the eleven bidders did not pass File 1's eligibility requirements and did not move on to subsequent files.

The winning bid showed project references with strong correlation to the RFP's requirements and scope, with further evidence of experience both within the public sector and healthcare systems.

The winning bid demonstrated their group experience within the area of Medicaid and CMS reporting and federal funding requests and had detailed responses for both PM and OCM showing their experience with both disciplines. The bidder also provided comprehensive templates for the required attachments.

V. Cost Proposal

The highest proposed cost was \$7,836,632.50. The lowest proposed cost was \$1,845,500.00. Public Consulting Group's cost was \$2,225,200.00.

The equation used to determine the scoring of cost proposals is as follows:

(Lowest submitted cost proposal / Cost of proposal being scored) x 25 = pro-rated score

VI. Conclusion

Public Consulting Group was the highest scoring Bidder. The proposal stood out due to the strong reference projects and experience with MES projects with multiple states as an OCM vendor. Their proposed services were backed by strong, well-documented responses, making them a reliable choice for a conditional award.




