The request must be made to the Director of the Bureau of General Services, in writing, within 15 days of notification of the contract award as provided in 5 M.R.S. § 1825-E (2) and the Rules of the Department of Administrative and Financial Services, Bureau of General Services, Division of Purchases, Chapter 120, § (2) (2).

This award decision is conditioned upon final approval by the State Procurement Review Committee and the successful negotiation of a contract.

Description of the Bidder's experience and ability to perform the work required within this RFP.

Adoptive and Foster Families of Maine, Inc. (AFFM) possesses significant experience and a demonstrated ability to perform work that effectively supports resource families. Established in 1997, AFFM has a long-standing history of supporting adoptive, foster, and kinship families across Maine. Starting as a grassroots volunteer effort, AFFM quickly evolved into a statewide organization, securing a statewide contract within two years, highlighting its capacity to handle large-scale support.

AFFM's experience is further evidenced by its extensive collaborations with key stakeholders, including the University of Maine Center on Aging (CoA), the Department of Health and Human Services (DHHS), the University of Southern Maine, Maine Alliance of Family Organizations (MAFO), and Generations United. These partnerships have enabled AFFM to develop and deliver impactful initiatives such as the "Community Conversations" training and the Resource Parent Bill of Rights Policy.

AFFM's deep understanding of the needs of resource families is underscored by their active involvement in numerous state and national councils, including the National Foster Parent Association and the National Advisory Council to Support Grandparents Raising Grandchildren, the Maine Child Welfare Action Network, and the Resource Parent Advisory Committee. This engagement keeps AFFM at the forefront of best practices and policy developments. Notably, AFFM was recognized as the Parent Group of the Year in 2013 by the North American Council on Adoptive Children for its dedication to supporting permanency for youth. In 2024, the Grandfamilies & Kinship Support Network: A National Technical Assistance Center designated AFFM's Kinship Program as an exemplary program.

AFFM has a proven track record of securing and managing funding to expand its services, including specific funding for kinship family support from the John T. Gorman Foundation and the Brookdale Foundation, and additional state and federal grant funding for kinship navigational services. This demonstrates their ability to manage resources effectively and respond to the community's evolving needs.

The agency's growth from a volunteer-run operation to a staffed organization of 30 individuals, many with lived experience as resource families, showcases their organizational capacity and commitment to providing peer-informed support. AFFM currently connects with over 7,000 individuals annually statewide, offering a wide array of services including peer navigation, training, emergency financial assistance, and material goods. Satisfaction surveys indicate that over 85% of resource families feel AFFM's services support their experience, and 91% find their services helpful in maintaining safe and stable homes for youth.

Their programs, such as the campership program, Snowbuster Program, and provision of material goods, demonstrate a comprehensive approach to supporting the diverse needs of resource families. The designation of AFFM as an exemplary program by the Gand Families and Kinship Network in 2024 further validates their expertise and effectiveness in this field.

In conclusion, AFFM's extensive history, collaborative partnerships, proven ability to secure and manage funding, dedicated and experienced staff, broad service delivery, and positive outcomes demonstrate their strong capacity and experience to effectively perform the work required within this RFP.
