


Location of Monitoring Stations

- Mechanic Street station (SPMS) began collecting 24-hour samples on March 23, 2021





Summary of Acute Health Risks




For the 16 chemicals with acute MRLs, none of the individual 24-hour sample results exceeded acute toxicity values




Cumulative Average-to-AAG Ratios for Individual Chemicals with AAGs (Feb 2022)



Cumulative Lifetime Cancer Risk (# per million)







Year 1 vs. Year 2 - Acrolein




Acrolein - Cumulative Average 24-hour Sampling Results with 95% Confidence Interval by Station

Year 1 vs. Year 2 - Naphthalene




Naphthalene - Cumulative Average 24-hour Sampling Results with 95% Confidence Interval by Station




