**FINDINGS OF FACT**

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

**I. Registration**

MS Ambrogio North America LLC has requested the transfer of Air Emission License A-152-71-M-M/T from Industrial Connections & Solutions LLC to MS Ambrogio North America LLC through a letter to the Department dated October 12, 2021. Air Emission License A-152-71-M-M/T was issued to Industrial Connections & Solutions LLC on August 16, 2018. The facility performs electroplating and metal finishing.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

**II. Transfer Requirements**

A. Title, Right, or Interest

In their application, MS Ambrogio North America LLC submitted copies of property deeds transferring ownership of the facility to MS Ambrogio North America LLC. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Technical Capacity and Intent

MS Ambrogio North America LLC's acquisition of the facility is not expected to result in any significant change in the employees who currently operate the equipment and facilities and conduct activities relevant to the air emission license. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence that MS Ambrogio North America LLC has the technical capacity and intent to comply with their air emission license.

This License Transfer shall be construed and enforced in all respects as if such invalid or unenforceable provision or part thereof had been omitted.
