25.1 Public Information Meeting

In accordance with the DEP Rules, Chapter 2, Three Rivers Solar Power, LLC has provided all necessary public notices to abutting property owners, the local municipality office, and to a newspaper which is circulated in the area where the Site Location project is located.

Please take notice that Three Rivers Solar Power, LLC (89 Main Street, Yarmouth, ME 04096, Tel: 857-315-5292) is intending to file a Site Location of Development Act permit application and a Natural Resources Protection Act application with the Maine Department of Environmental Protection pursuant to the provisions of 38 M.R.S.A. §§ 481 through 490 and 38 M.R.S. §§ 480-A to 480-BB on October 25, 2019.

The application is for a 100 MW solar power generation facility, located in Township 16MD BPP, Hancock County, Maine.
