25.1 Public Information Meeting

In accordance with the DEP Rules, Chapter 2, Three Rivers Solar Power, LLC has provided all necessary public notices to abutting property owners, the local municipality office, and to a newspaper which is circulated in the area where the Site Location project is located.

On August 2, 2019, a public notice of a public information meeting (Exhibit 25-1) was sent to all abutting property owners and the Hancock County Commissioners (local municipality). 

The application is for a 100 MW solar power generation facility, located in Township 16MD BPP, Hancock County, Maine.
