

SECTION 25 NOTICES

The Applicant has provided all necessary public notices to abutting property owners, the local municipality office, and to a newspaper, which is circulated in the area where the Project is located.

On April 26, 2021, a public information meeting notice (Exhibit 25-1 [Public Meeting Notice]) was sent to all abutting property owners and the Town (local municipality). A list of the abutting property owners is provided in Table 25-1 and the relative location of each abutting parcel is depicted in Figure 25-1. U.S. Postal Service Certified Mail Receipts are provided in Exhibit 25-2 (Public Meeting Notice Mail Receipts). The public notice also was published in the *Morning Sentinel* newspaper that is distributed in the area where the Project is located on April 28, 2021 (Exhibit 25-3 [Public Meeting Notice Tear Sheets]), and provided to the Town, to be posted on the community bulletin board available in the Town office and on the Town’s website.

A Microsoft Teams virtual public information meeting was held on May 6, 2021 in accordance with MDEP rules (06-096 CMR 2). One member of the public, municipalities, or agencies attended the public meeting. The Applicant presented information summarizing the Project, the avoidance and minimization of environmental impacts of the Project, the permits that will be applied for and obtained prior to Project development, and the MDEP public participation fact sheet. The meeting sign-in sheet and certification form (Form C) are provided in Exhibit 25-4 (Public Meeting Sign-In Sheet and Public Notice Certification [Form C]).

On June 18, 2021, a Notice of Intent to file (Exhibit 25-5 [Notice of Intent to File]) was sent to abutters and to the local municipality. U.S. Postal Service Certified Mail Receipts are provided in Exhibit 25-6 (Notice of Intent to File Mail Receipts). A public Notice of Intent to file was circulated in the *Morning Sentinel* newspaper, on June 21, 2021 (Exhibit 25-7 [Notice of Intent to File Tear Sheet]). A copy of the Notice of Intent to file also was provided to the Town to be posted on the community bulletin board available at the Town Office and on the Town’s website.

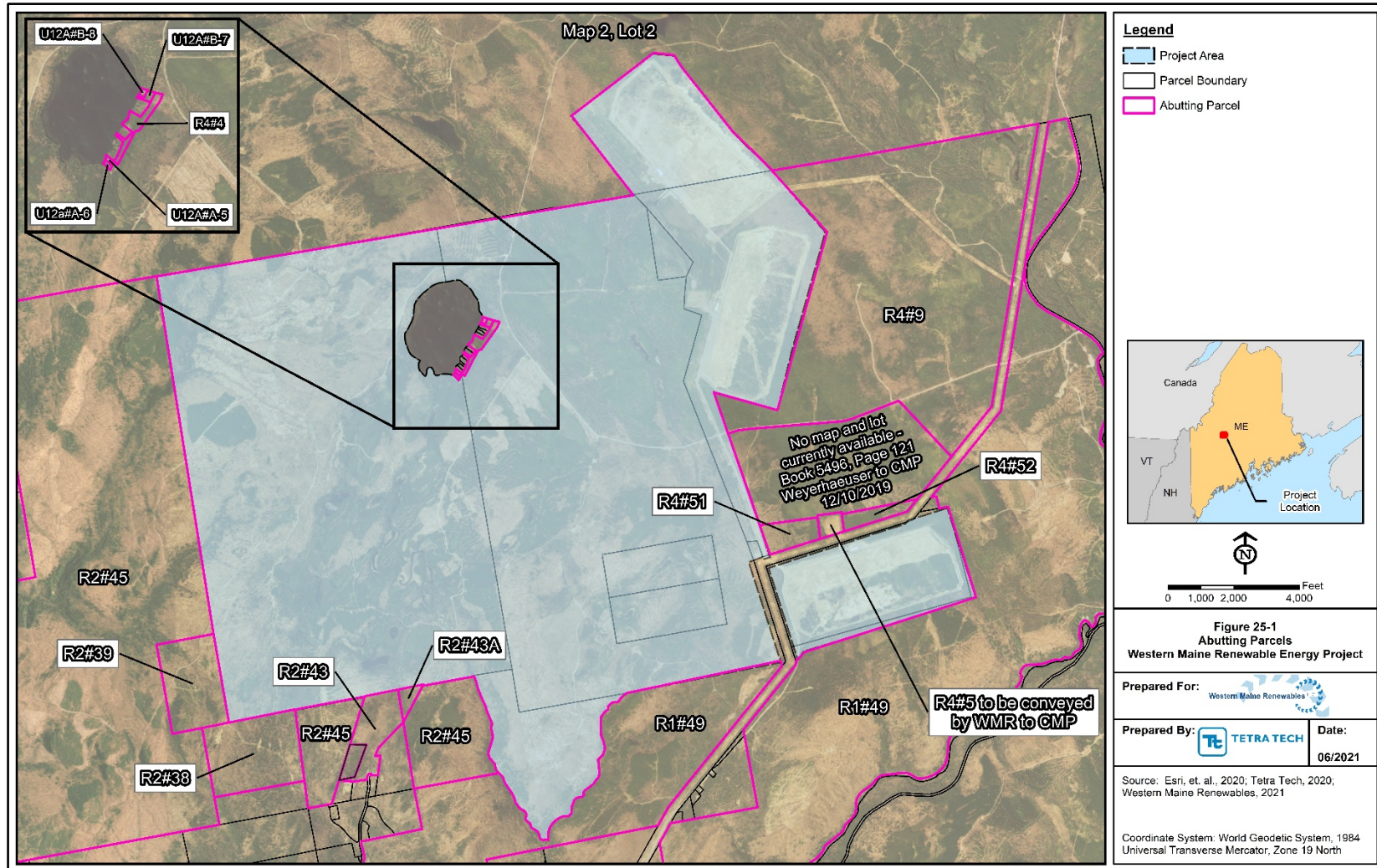

PUBLIC NOTICE FILING AND CERTIFICATION

The DEP Rules, Chapter 2, require an applicant to provide public notice for all Site Location projects with the exception of minor revisions and condition compliance applications. In the notice, the applicant must describe the proposed activity and where it is located. "Abutter" for the purposes of the notice provision means any person who owns property that is BOTH (1) adjoining and (2) within one mile of the delineated project boundary, including owners of property directly across a public or private right of way.

1. **Newspaper:** You must publish the Notice of Intent to File in a newspaper circulated in the area where the activity is located. The notice must appear in the newspaper within 30 days prior to the filing of the application with the Department. You may use the attached Notice of Intent to File form, or one containing identical information, for newspaper publication and certified mailing.
2. **Abutting Property Owners:** You must send a copy of the Notice of Intent to File by certified mail to the owners of the property abutting the activity. Their names and addresses can be obtained from the town tax maps or local officials. They must receive notice within 30 days prior to the filing of the application with the Department.
3. **Municipal Office:** You must send a copy of the Notice of Intent to File and a **duplicate of the entire application** to the Municipal Office.

ATTACH a list of the names and addresses of the owners of abutting property.


