Winter Warming Shelters Update	 First Parish Church and Commonspace have partnered to establish a low barrier warming shelter for the 2024-2025 winter season. The shelter will be funded by Maine State Housing Authority, operated by Commonspace, and located in First Parish Church. We are working collaboratively to finalize logistics of operations and activation; once those are ironed out we will share more widely but wanted to get this out to the group as temps get colder. Municipality inform the county EMA, and County EMA then informs the main EMA, MEMA; then that is posted on the MEMA website.

Allie Harvell- Thanksgiving 2024 Holiday Meal Guide. Creating one for the Christmas/ winter season. Created flyers to help promote Flu and Covid vaccines. Currently got the "OK" for both the Spanish and English versions

Anna Bullitt (WIC director)- Maine Youth Action Conference in Augusta with colleagues and 550 middle and high schoolers.

Michaela Maynard AHEC Scholars Program with the Center for Excellence in Public Health of UNE- Share the good work of their main AHEC team this past weekend thanks to the annual case competition. where health profession students work on interprofessional teams to come up with interventions and creative solutions that address complex population health issues. This year's case addressed maternal health with the asylum-seeking community in southern Maine there's a link, so I will share that. We will share that thing up soon.

Cathy Bean Kelly- NLHC participating in perinatal postpartum moms for hypertension. Pregnant individuals will receive a blood pressure cuff in hospital; Team will monitor the readings and follow up promptly with their provider back to the hospital depending on what their reading is.

Courtney Kennedy (GSFB)- Reminder EBT and SNAP shoppers can take advantage of half off their produce through Farm Fresh Rewards or even Maine Harvest Bucks. At farmers markets is a little different model where for every \$10 spent, they receive \$10 on local food.

Sarah Lewis (MAIN)- in office Dental clinic has openings on December 5. As soon as patients are scheduled we can help them complete new patient registration form for Mainly Teeth. The spots are open to anyone; very targeted community at Main Access Immigrant Network, but its open to anyone; preferred Maine care.
