- Conducted latest virtual Local Health Officer (LHO) training regarding Browntail Moth related issues

Healthy Aging

- No healthy aging meeting this quarter a lot of the same members of this committee sit on ACHIP project.
- Stacy attended BOLD webinar regarding dementia screening. There is an identified need to better link treatment options with home workers – BOLD is currently developing those tools.

Emergency Planning

- Completed pandemic plan for respiratory illness.
- AKEMA is working on extended power outage plan working with the University on language and how to prioritize who would get power first.
- Continued effort on adapting the Healthcare Coalition (HCC) structure in Maine
- Next Friday convening impromptu meeting to discuss potential impacts of the influx of people coming to area to view Eclipse and how that might affect hospitals, medical transport, and public health.
- Initiated discussions regarding hazard vulnerability analysis and where our gaps are.

Presenters: AMHC

Residential Treatment Facility (Rebecca Fournier)

- Relocated the "FARM" to Presque Isle to expand number of beds and change the type of service provided. Not previously a withdrawal management facility and can now provide clinical withdrawal services (must be medically cleared first).
- Hired a nurse and have an MOU with NL ARG to give the proper level of care.
- Went from 8 to 18 bed capacity, however not currently able to be full capacity due to workforce issues.
- Sees a need for medical withdrawal facility in the area but needs to be partnering with a residential treatment facility directly after.
- 70% retention success rate

OPTIONS Liaison (Marshall VanHollow)

- Empower people to help their community, Aroostook County has a higher overdose rate per 1000 people than Cook County, Illinois (Chicago).
- Conducted a training on how to utilize Narcan
- Narcan distribution through pharmacy, options liaison, or Maine Access Points.

Emergency Services & ACSU (Christina Wall)

- AMHC Adult Crisis Unit located in PI individuals can selfrefer or can have referral from case managers, therapists, physicians by calling directly 207-768-3304. Program is voluntary – client must be willing and med-compliant.
- Move to Academy Street increased beds from 5 to 8.
- Current barriers include lack of staffing to support 8-bed facility and lack of resources to support a safe and stable discharge plan.

Partner Updates:

- Theresa Dow (ACAP) Maine Prevention Network (MPN) update currently getting approval for 2024 contract year. Tobacco program had first peer leadership catch my breath training rolls out in Valley and FK middle school. HEAL program still has the lending library program. SUPS program recently completed 2 community programs for Narcan working with public health district in Bangor and MaineGeneral. In process of getting mail back envelopes for sending in unneeded prescription drugs in Houlton, FK, and PI to safely dispose medications. Doterra bags are available at AAA and can provide to community members if needed. Safe storage containers and lock boxes are also available.
- Judy Anderson Access Point Project up and running- have signed MOUs with satellite offices. Memory Care center is still waiting to open, but currently taking referrals. ACHIP grant is full steam ahead – work on transportation subcommittee and has been moving along.
- Gabe- MYAN winter training series for youth engagement best practices. Launched gateway program for youth employment partnering with ACAP.
- Jane HCH reviving blood pressure clinic and working on getting clinics into different communities.
- Sue Powers last week Maine Housing announced that they were ending Home Energy Assistance applications on March 1. All outstanding appointments past March 1 were scheduled in February to meet need.
