## What Is an EOP and What Does It Do?

- An emergency operations plan (EOP) is a key component of an emergency management program that establishes the overall authority, roles, and functions performed during incidents.
- Assigns responsibility to organizations and individuals.
- Sets forth lines of authority and organizational relationships and shows how all actions will be coordinated.
- Describes how people and property are protected.
- Identifies personnel, equipment, facilities, supplies, and other resources.
- Reconciles requirements with other jurisdictions.
- Is flexible enough for use in all emergencies.



# Maine CDC All Hazards Emergency Operations Plan



## Who is Responsible for Maintaining the Maine CDC EOP?

- The Public Health Emergency Preparedness (PHEP) team will assist with updating these documents on a set review cycle through the Emergency Preparedness Work Group (EPWG) and additionally if documentation after an incident reveals weaknesses to be resolved.
- The Maine CDC Emergency Preparedness Work Group will complete an internal annual review of the Plan annually.
- The PHEP staff will ensure that the Plan is reviewed by the stakeholders and appropriate SMEs every three to five years to review any changes to the Plan and to further revise as indicated.
- The public health Functional Annexes, Hazard Specific Annexes, and the Support Annexes are developed by the SMEs in the functional components of the Maine CDC, in collaboration with the HCC-ME, the District Liaisons (DLs), the County Emergency Management Agencies (CEMAs), Maine Emergency Management Agency (MEMA), and other appropriate emergency preparedness and response partners.
- The Plan will also be updated to reflect Lessons Learned as they emerge from After Action Report/Improvement Plans with corrective actions following real events or planned training exercises.

## What is in the Maine CDC EOP?

- The EOP is divided into the following components:
  - Base Plan – The Basic Plan provides an overview of the jurisdiction’s approach to emergency response operations.
  - Functional Annexes - Functional annexes are plans organized around the performance of a broad task. Each annex focuses on one of the critical emergency functions that the jurisdiction will perform in response to an emergency.
  - Hazard Specific Annexes - Hazard-specific appendices provide additional detailed information applicable to the performance of a particular function in the face of a hazard.
