

Melanoma is **not** a leading cause of cancer death.

The 5-year relative survival is **93.5%**.²

Maine ranks **29th** in the US for melanoma 5-year survival rate. ³

Risk Factors

- Sun exposure
- Race (white)
- Having many or abnormal moles
- Having fair complextion (blue or green eyes, blonde or red hair)

MAINE CDC CANCER REGISTRY (MCR)



The MCCCP is funded by Maine's Centers for Disease Control and Prevention.


The program provides leadership and coordination of Maine's statewide comprehensive cancer control efforts and is guided by the goals and objectives outlined by the Maine Cancer Plan.
