SNOWMOBILE GROOMER APPLICATION

In accordance with the provisions of the Revised Statutes, Title 12, section 13113, subsection 3.

The commissioner may register trail-grooming equipment upon application by the owner if the owner is a nonprofit organization that has an approved contract for snowmobile trail grooming with the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands, Off-Road Vehicle Division or a person that can provide proof to the department at the time of application that the person is a member of an organization eligible to register trail-grooming equipment under this section. The commissioner may establish procedures necessary to carry out the purposes of this section.

- 1.) In order to issue a Groomer registration for the club/association/individual, the machine must fit the definition of a "Trail-Grooming Equipment" and be performing snowmobile trail maintenance by plowing, leveling or compacting snow by use of a front plow or rear attachments that include but are not limited to rollers, compactor bars or trail drags. This registration is valid until transferred to another owner.
- 2.) Please submit, along with this application, a copy of the bill of sale and the "Affidavit of Exemption" for the sales tax. **Failure to provide all three documents will result in application denial and will be sent back with a formal letter.** If you have any questions, please feel free to call us at 207-287-8000 and ask to speak with "Licensing and Registration".
- 3.) If you plan to register the Groomer in a personal name, you MUST submit proof that you are a member of the Snowmobile Club that you will be performing trail maintenance for.

The registration fee for a Snowmobile Groomer is \$34.
