BRIEF SUMMARY: The Department of Inland Fisheries and Wildlife is proposing allocation numbers for moose hunting permits to be issued for the 2026 moose hunting season. Permits will be issued for antlered and antlerless moose. This proposal also includes the discontinuation of the Adaptive Management moose hunt referred to as WMD 4a, which was established as a 5-year research project and has now concluded. Proposed permit allocations according to Wildlife Management District are as follows:

WMD 1 – 450 antlered / 175 antlerless

WMD 2 – 350 antlered / 175 antlerless

WMD 3 – 200 antlered / 125 antlerless

WMD 4 – 400 antlered / ~~100~~ 250 antlerless

~~**WMD 4A (adaptive hunt)** – 550 antlerless~~

WMD 5 – 250 antlered / 125 antlerless

WMD 6 – 200 antlered / 60 antlerless

WMD 14 & 17 (combined) – 40 antlered

WMD 16 – 0 permits

WMD 18 – 40 antlered

WMD 19 – 60 antlered

WMD 27 & 28 (combined) – 40 antlered

Principal Reason(s) or Purpose for Proposing this Rule [see 5 M.R.S. § 8057-A(1)(A)]:

Moose permit numbers are adjusted on an annual basis in response to moose population estimates and population goals in each Wildlife Management District (WMD). Department biologists use moose harvest levels, aerial surveys, and biological data to evaluate the status of moose within each WMD. This information is compared to publicly derived goals outlined in the moose management system to determine whether the population in an individual WMD should be stabilized, increased, or decreased when making annual permit recommendations. This permit allocation also addresses ongoing concerns about the impacts of winter tick on moose survival and productivity while continuing to provide hunting opportunity across Maine’s moose range.

Analysis and Expected Operation of the Rule [see 5 M.R.S. § 8057-A(1)(B) & (D)]:

For the 2026 season, the Department is recommending 3,705 permits be issued statewide to meet our moose harvest objectives. This proposal includes the discontinuation of the Adaptive Management moose hunt referred to as WMD 4a, which was implemented for five years beginning in 2021. This hunt, which was established as a 5-year research project, has now concluded and the Department will be analyzing the results before recommending adjustments to moose hunting permit levels in future years. Therefore, this proposal recommends a total of 2,645 antlered moose permits, and 1,060 antlerless permits statewide. The proposal also removes the reference to the Adaptive Hunt in Chapter 16.

Brief Summary of Relevant Information Considered During Development of the Rule (including up to 3 primary sources relied upon)[see 5 M.R.S. §§ 8057-A(1)(E) & 8063-B]:

Adjustments to moose permit numbers are based on the Department’s Moose Management System, which was developed as part of our long-term species planning process. This comprehensive system includes an extensive scientific assessment of moose populations and management strategies. Our management approaches are also reviewed and discussed on an annual basis with other moose biologists across the

northeastern U.S. and eastern Canada. Currently, we collect and analyze several types of data to develop informed recommendations on moose permit numbers. These data sources include helicopter surveys to estimate moose numbers and herd composition, hunter success rates, ages of harvested moose, and reproductive rates.

3. Moose Permits

For the purposes of this rule, the following terms have the following meanings:

A.

- (1) **Antlerless moose:** means a moose without antlers;
- (2) **Antlered moose:** means a moose with antlers; and
- (3) **Any-moose:** means a moose of either sex.

B. The number of moose hunting permits to be issued for each WMD shall be as follows:

9. Adaptive Management Hunt Location

A. **WMD 4A North:** Beginning at the point where the St. Aurelie Road intersects with the Quebec Border in Big Six township then northerly along the Quebec-Maine border to the point where the American Realty Rd. intersects the Maine-Quebec border in T11R17 WELS; then following the American Realty Rd. easterly to the Maibee Connector Rd. (also known as the Thibodeau Connector Rd.) south to the intersection with the Ross Mountain Rd., then east on the Ross Mountain Rd. to the intersection with the St. Juste Connector Rd., then southwesterly to the intersection with the St. Juste Rd., then easterly along the St. Juste Rd. to the intersection with the St. Aurelie Rd., then south along the St. Aurelie Rd. to the intersection with the Caucomgomoc Road. Then westerly along the St. Aurelie Road to the Quebec border,

B. **WMD 4A South:** Beginning at the point where the Golden Rd. intersects the Maine-Quebec border in T5R20 WELS; then following the Maine-Quebec border northerly to the point where the St. Aurelie Rd. intersects with the Quebec border in Big Six township; then following the St. Aurelie Rd. easterly to the intersection with the Caucomgomoc Rd., the southeasterly along the Caucomgomoc Rd. to the intersection with the Russell Mountain Rd. then southwesterly along the Russell Mountain Rd. until the junction with the 490 Rd. the southerly along the 490 Rd. to the Golden Rd., then westerly to the start at the Canadian Border.

D. Training for eligible participants

Each hunter selected must attend a training session conducted by the department before being issued their moose hunting permit. A selected hunter who fails to attend the required training session will forfeit their permit.
