Chair's Message



It is a great honor to serve as the chair of the InforME Board. This is my fourth year as Chair and each year I am more impressed with all that InforME accomplishes.

In 2022, we executed the third InforME Network Manager contract. This new contract calls for several new and exciting initiatives focused on infrastructure, services, and community outreach. As planning begins under this new contract, the Board has met regularly to discuss strategic planning and the long-term vision for InforME. This planning revolves around collaboration across departments and lending InforME's best practices to all of state government.

While the opportunities from the new contract lend themselves to an exciting and innovative future, I would be remiss to disregard the importance of the accomplishments in 2022. Eleven critical agency websites, including for the Department of Marine Resources and the Governor's Office were designed in the InforME content management system. These new sites offer a better, more consistent user experience for the public while simplifying the way Maine's agencies manage website content.

29 interactive services were deployed in 2022 to further provide efficiencies for agencies and the public. One of the new services that had significant impact is the deer permit purchase service. Due to legislation passed in early 2022, a new program was established that requires hunters to claim the deer permit they were awarded from the deer permit lottery by paying a statutory fee. This entirely new business function for the Department of Inland Fisheries and Wildlife was used by more than 58,000 hunters resulting in thousands of deer tagged during the Fall Hunting season using the online InforME Game Tagging solution.

This new service joins our ever-expanding suite of over 200 online offerings – offerings that we must consistently reassess to make sure they deliver meaningful user experiences. To this end, InforME deployed 35 service enhancements to the existing services. These enhancements were driven by user feedback, legislative changes, or by agency request.

As we look forward to 2023 and our first full year under the new Network Manager contract, I would like to thank all of the agencies, municipalities, InforME Board Members, and service users for helping us grow over the past 24 years to the place we are at right now. With strategic vision and planning, InforME will continue to elevate Maine's role as a leader in digital government.

2022 - A Year of Success

Maine.gov, developed by InforME, is a gateway to State of Maine information and resources accessed through one-stop services, convenient notification options, and excellent customer service. After 24 years in operation, InforME continues to combine advanced technologies with user-friendly design to meet the service needs of citizens, businesses, and state government.

In 2022, InforME processed nearly 3,000,000 transactions totaling \$250,000,000 in revenue for our state and local partners across 200+ unique service offerings. InforME served more than 62,000,000 website visitors over the 12-month period through its hosted websites under Maine.gov. These services, complete with agency database interaction and credit card payments where necessary, plus the robust hosted content available through Maine.gov have saved trips to town offices, calls to state agencies, and emails to support staff.

InforME is proud of the work accomplished and carefully balances an ever-evolving set of user requests against agency and statutory rules and requirements. In 2022, InforME deployed 40 new websites and interactive online services and 35 service enhancements. This extensive portfolio of new development was expedited through the use of InforME platforms including the Form Builder and the Content Management System.

The form builder is a low-code system developed by the private partner to InforME, NIC, a subsidiary of Tyler Technologies. This tool allowed InforME to create 22 online services including fraud reporting forms, municipal recreation program sign ups, tax return filing forms, grant forms, and payment portals.

The form builder has transformed several outdated paper processes into end-to-end digital solutions including the ability to calculate and take payment when necessary. These solutions were created in hours, and in some cases could be deployed within a week of

the initial service request. The form builder has gained significant traction since its launch and fills the need for the digital solutions that agencies have against time and budget constraints.

The enterprise content management system leverages modern technologies and enhances the website creation and editing process for state program administrators. In total, 11 new sites were launched in the platform during the year including the Maine Office of Business Development, the Governor's Bipartisan Infrastructure Law website, and the Bureau of Financial Institutions. Website redesigns of the Department of Health and Human Services Centers for Disease Control and the Maine Department of Transportation are in progress, with deployments scheduled in 2023.

Looking Forward to 2023

In the coming year, InforME will continue to expand state and local government services and information by leveraging platform technologies such as the form builder and the content management system. This will allow us to quickly transition new services online. With the deployment of several exciting new services, websites, and initiatives on the roadmap for 2023, InforME is looking forward to another year of success.

Deer Permit Purchase

InforME developed and launched a new service allowing hunters to purchase their deer permit online. This new program, available in September 2022, deployed after the lottery was drawn allowing hunters to claim their permit. A second portion of the service launched in October and allowed hunters to purchase up to 3 additional permits for WMDs throughout the state. The service was used by more than 58,000 hunters.



Inland Fisheries and Wildlife // Game Tagging
Multiple enhancements were released prior to fall 2022 hunting seasons. The IFW administrative site can now manage deer permits and the system integrates with the new online deer permit purchase service. The service also added support for new Wildlife Management District subunits. No fees. April 2022
