Please be advised that The Manufactured Housing Program does not have statutory authority to handle landlord/tenant issues in manufactured housing communities. You may contact the Maine Office of the Attorney General at (207) 626-8800.

If you have contacted the community owner and the problems continue to exist, send to Complaints Division at the address above, as soon as possible. You may wish to make a copy for your personal records. Also, please send us a copy of all papers pertinent to your complaint.

NOTE: If you fail to provide the requested information, our investigation of your issues may be delayed.

MRS Title 10, Chapter 951, Subchapter 6 § 9086 Right of Entry and Inspection

The MHP and any duly designated officer or employee thereof may enter upon the premises of any manufactured housing community licensed pursuant to this subchapter at any reasonable time in order to determine the state of compliance with this subchapter and any rules in force pursuant to this subchapter.
