# Our Mandate Begins



In 2023 our State Legislature amended the law, **requiring the BMV** to issue a replacement to all Chickadee plates starting May 1, 2025.



Many Chickadee plates are:

- Old,
- In disrepair, and
- Have lost their reflectivity.





# Not Your Average Project

Over 1,200,000 - - - - ->

The number of Chickadee plates that are going to be replaced during the issuance.

1,682,405 - - - - ->

The number of registered vehicles in Maine on January 1, 2024 alone.



# The Big Numbers



This data shows over 71% of all license plates in Maine are going to be replaced during a **one-year span.**

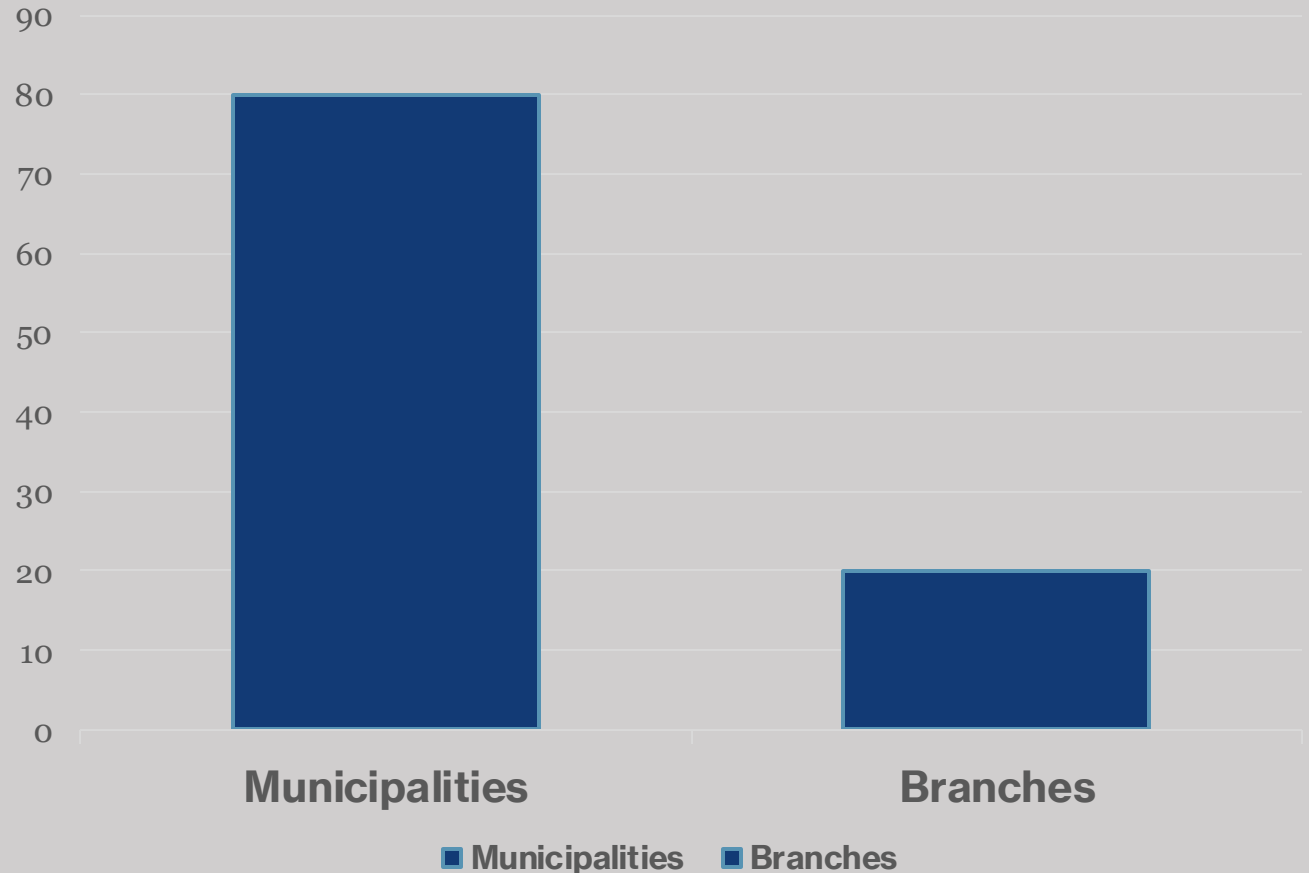




# You Are Our Foundation

# Let's See Those Plates Again



Pine Tree Plate replacing the Chickadee as the new general issue plate.



No Tree Plate is an alternative option for the **PC Class Code only.**



# → What's the Big Deal?

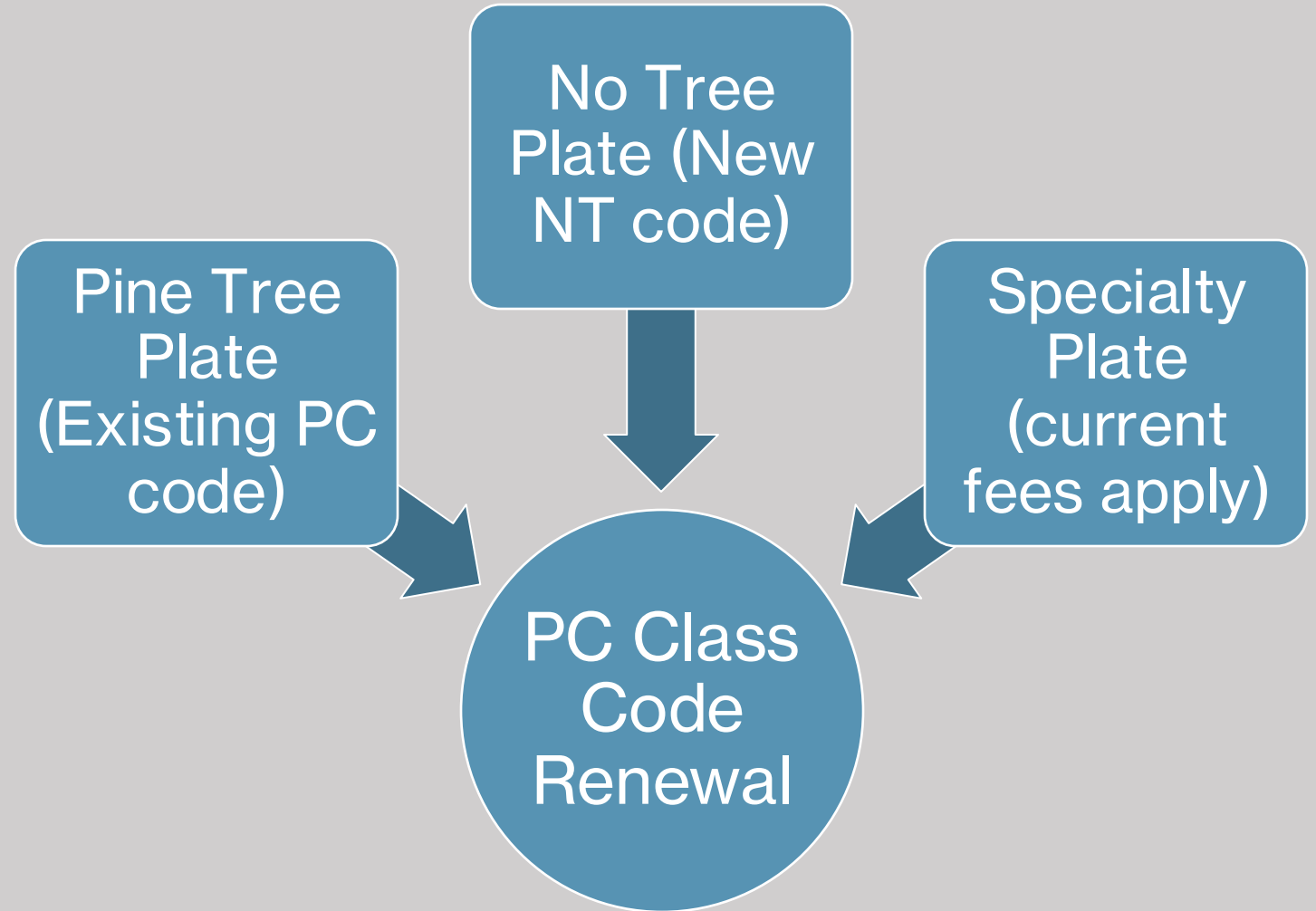
So, what is the difference when it comes to a license plate reissuance?

When it begins on May 1, 2025, not a single Chickadee plate **of any kind** will be issued from that point forward.

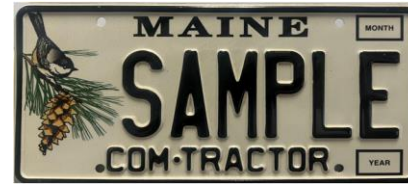

# What You'll Carry



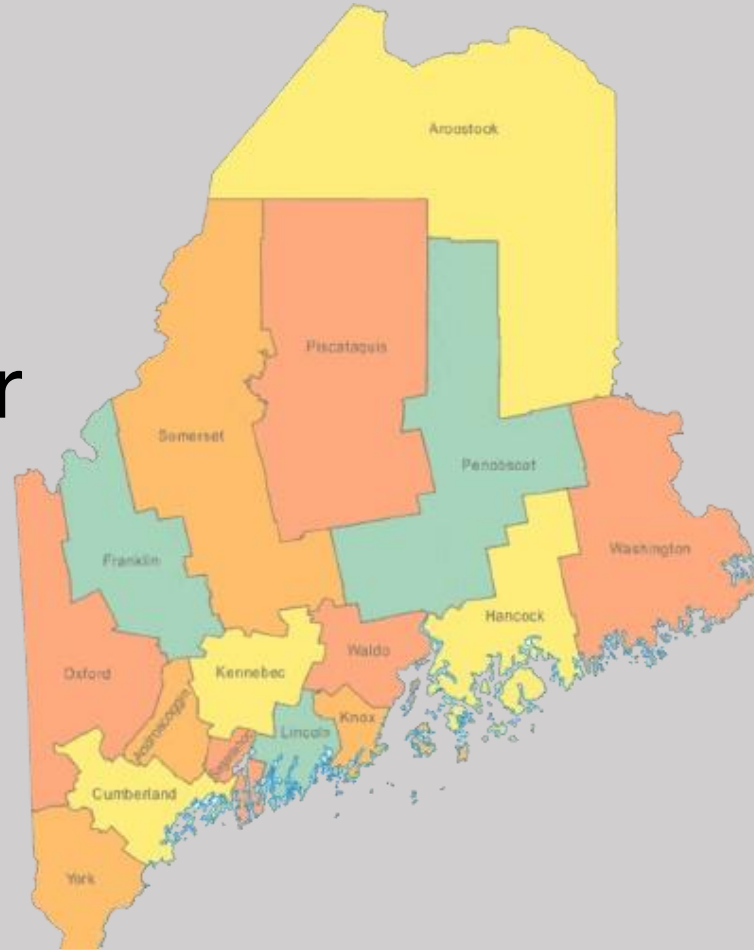
During the issuance, all cooperating Limited New Municipalities **must carry** some plate classes outside of their typical authorization level.

The BMV has been working with third party vendors (TRIO, MUNIS, Northern Data) to support these changes.



# What You'll Carry

During NPI you will be authorized to carry plates only for the exchange of a customer's existing Chickadee plate.



The Limited New Authorization Level means you carry these classes:

- NT
- AQ
- CM
- CO
- CV
- DX
- FM
- MH
- SE
- TR
- TT
- SM

# New Numbering Sequences

**Starting May 1, 2025**, as per the New Plate Issuance Project, new numbering sequences will be added to all plates with the Pine Tree design, except DX, PC, and TT class codes.

These numbering sequences will not duplicate any current sequences.

# Plate Number Reservations



Registrants who would like to keep their current Chickadee plate numbers may reserve their plate for a \$25 one-time-fee.

Registrants who have an active vanity, low digit, and National Guard (PC Class Code) **must reserve their plates** if they would like to keep their current plate number.





# Plate Number Reservations

A license plate number can be reserved in **four different ways.**

# Plate Number Reservations

## Option One

Online through a standalone reservation portal ([maine.gov/online/reservemyplate](http://maine.gov/online/reservemyplate)).

## Option Two

They will be prompted if they use the Rapid Renewal website.

Option Three - - - → Going into a BMV branch office.

Option Four - - - → Mailing in a Reserve Plate Application (MV-62) to the BMV Administrative Office.





The MVR-3E layout will be modified to reflect the reservation information BMV will be exporting so data flows smoothly to towns.

Electronic Registrations will print the “Print Priority” phrase as “RESRV # FEE PD” on any registration completed that has the “R” reservation flag set for that record in the delta/preprint file data export from BMV.

# → Tractors and Special Mobile Equipment



Starting May 1, 2025, BMV is adding a new class code for Special Mobile Equipment.



# Tractors and Special Mobile Equipment

1

## Road Tractor

Designed and used primarily for drawing other vehicles, but not constructed to carry any load.

(Existing Class Code – TR)

2

## Farm Tractors and Homemade Tractors

Used primarily as a farm implement for drawing plows and mowing machines.

(Existing Class Code – TR)

3

## Special Mobile Equipment

Every self-propelled vehicle not designed or used primarily for transportation or property, but which are operated over the highway.

(New Class Code – SM)

# Special Mobile Equipment (SM) - - -



First-time issuance of the SM plates will be allowed from BMV branch offices and cooperating municipalities with the New or Truck level authority.

Both will also be able to renew special mobile equipment registrations.

Vanities, out-of-rotation plates, and low digit plates will **not be allowed** in the SM class code.

Due to the new Special Mobile class code, plate reservations are only allowed for tractors. These must be manually done, with forms sent to the BMV Administrative Office, Registration section for approval.

# How We're Getting It Done



In accordance with Public Law, c. 421 the BMV must replace the Chickadee plates.

The manufacturing shop in Warren, Maine cannot accomplish this. Waldale Manufacturing, based in Nova Scotia, was awarded this task.

Plate production begins in January 2025.



# → Some Things Change

- Plates are shipping **directly from Waldale** to their final destinations.
- Municipalities and branches **will not submit requests** for Pine Tree and No Tree plates on the MV-51 form.
- The quantity of plates each municipality, non-governmental agency, or branch needs is determined by **2023 actual new and renewal registrations.**



# → Some Things Change

- Waldale knows the 2023 actual new and renewal registration numbers and will send each location what they need for each month.
- The quantity for the first delivery covers inventory for **both May and June.**



# Others Stay the Same

While many things will change during the New Plate Issuance, there will be those that don't for New Registration and Truck Levels.

For Limited New during NPI you will:

- Get plates shipped via UPS,
- Receive plates in packaged boxes, and
- Use the same process as you do for sticker inventory to report incorrect quantities, class codes, or sequences.







# The Big Day

Shipments will be sent from Waldale starting March 1, 2025, so everyone has their plates by April 1, 2025, one month ahead of the new issuance.

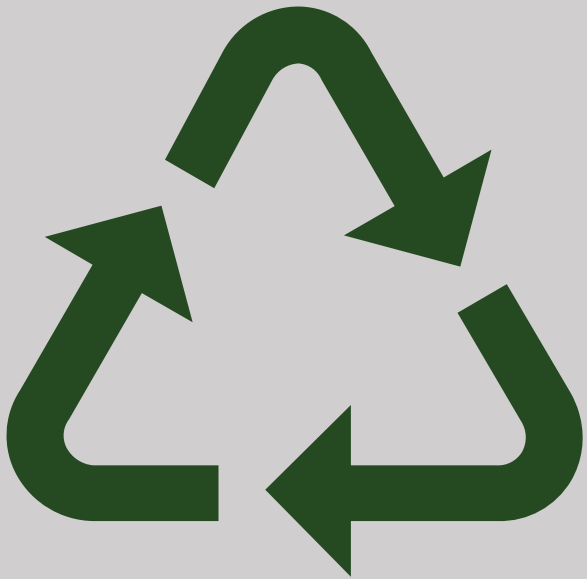
The issuance begins on May 1, 2025, and due to statute, the new plates **must not be issued** before May 1, 2025.



# → Taking Time to Recycle

In line with LD29A, BMV recognizes registrants may keep their old plates.

BMV's Administrative Office will plan for picking up and recycle returned and unissued Chickadee plates that remain.
