Report Summary

Pursuant to <u>Title 13-C</u>, <u>Chapter 8</u>, <u>Subchapter 1</u>, <u>§803</u>, this report provides a preliminary overview of domestic publicly held corporations and the gender parity of each entity's corporate board. This report relies on public reporting of domestic corporations, and there may be some errors in the reported information.

Exhibit 1 in the attached spreadsheet provides a list of corporations in Maine that self-identified as publicly held in annual reporting to the Department of the Secretary of State, Bureau of Corporations, Elections and Commissions. Due to suspected errors and evident confusion about the term "publicly held," staff checked the list against the NASDAQ and New York Stock Exchange (see Exhibit 1, Column F). Of the 283 corporations that self-reported as publicly held, staff identified six publicly held corporations using this approach (See Exhibit 2). Re-design of data collection tools is underway to address the limitations of this methodology and to mitigate future errors.

Exhibit 3, Column F, indicates compliance or noncompliance with the gender parity requirement outlined in state statute. The gender parity formulas used to determine compliance are indicated below and can also be found in statute:

- If the number of directors on its board of directors is 6 or more, the corporation shall have a minimum of 3 female directors.
- If the number of directors on its board of directors is 5, the corporation shall have a minimum of 2 female directors.
- If the number of directors on its board of directors is 4 or fewer, the corporation shall have a minimum of one female director.

50% of domestic publicly held corporations (3 out of 6) were found to be in compliance with the gender parity requirement. See Exhibit 3 or the below table for additional detail about each corporation and the gender makeup of each board.
