AMENDMENT TO REGULATORY AGENDA

FINANCE AUTHORITY OF MAINE

Pursuant to 5 MRSA §8064, the Finance Authority of Maine submits the following amendment to its current Regulatory Agenda:

- 1. A. Rule Name: Chapter 601, Amendment 12: Maine State Grant Program
 - B. Statutory Basis: 20-A M.R.S.A. § 11616(2); P.L. 2019, c. 343; P.L. 2019, c. 654
 - C. Purpose of Rule: Conforms the governing program rule with statutory changes made by the Legislature with respect to adult learners. The proposed rule defines "adult learner" and extends from ten semesters to twelve semesters the length of time during which an adult learner may avail themselves of the grant. It also makes certain technical changes with respect to punctuation and spacing in the current rule.

Approval by FAME Board: June 2022

Public Hearing: None proposed

Adoption: August 2022

- E. **Potential Beneficiaries and Regulated Parties:** Maine's adult learners wishing to return to higher ed and obtain assistance in paying for it. \$2,500 grants (full-time) or \$1,500 grans (part-time) available to encourage completion of degrees and to help meet workforce needs.
- 2. A. Rule Name: Chapter 618, Amendment 2: Maine Veterinary Medicine Loan Program
 - B. Statutory Basis: P.L. 2021, Ch. 725; 20-A M.R.S.A. §§ 12121-12125
 - C. **Purpose of Rule:** To conform the existing rule governing the Maine Veterinary Medicine Loan Program with statutory changes recently made by the Legislature pursuant to LD. 1885, *An Act to Increase Maine's Veterinary Workforce*, now P.L. 2021, ch. 725. The Legislature amended the program to: increase the number of loans that may be awarded (funding permitting) from two per year to eight per year, with overall aggregate program loans increased from eight to thirty-two, but at least half of these (and no fewer than two) must be awarded to livestock veterinary students, unless FAME does not receive enough applications, in which

case it may award remaining loans to other eligible applicants; increase maximum loan amounts from \$25,000 per year to \$35,000 per year; expand program eligibility to veterinarians who practice "emergency and critical care"; and expand program eligibility to veterinarians of any kind who practice in "underserved geographic regions" (priority must be given to Aroostook, Oxford, Penobscot, Piscataquis, Somerset, and Washington Counties).

E. **Potential Beneficiaries and Regulated Parties:** Veterinary students interested in obtaining help paying for their education and possible loan repayment if subsequently employed in eligible facilities/areas. Also Maine veterinary practices/clinics, as well as large and small-breed animal owners seeking veterinary care in various parts of the state.
